

# General Sir John Monash: A man for all times

General Sir John Monash was recognised as a great leader on the battlefields of northern France in the First World War.

However, this seminal role was only part of his enduring legacy. He was an outstanding scholar, engineer, public servant and civic leader – the driving force behind the ANZAC commemorations and founding member of community bodies such as Rotary, as well as the remarkable repatriation of around 160,000 Australian troops; newly trained with professional and trade skills acquired in France and England while waiting for their safe passage to Australia.

An iconic nation-builder, John Monash was guided by a strong sense of duty and obligation, employing his talents and education to build a more cohesive society – creating opportunities for others as he went.

He is an inspiration to all Australians and the guiding spirit of the Foundation.

### **The Young Man**

John Monash was born in West Melbourne, Victoria, on June 27, 1865 to Jewish migrant parents from Prussia. In 1874, the family moved to the small New South Wales town of Jerilderie. They returned to Melbourne three years later and John Monash enrolled at Scotch College. At the age of 16, he graduated as equal Dux of the school.

### **The Scholar**

John Monash graduated from The University of Melbourne with degrees of Master of Engineering in 1893, Bachelor of Arts and Bachelor of Law in 1895 and Doctor of Engineering in 1921. He spoke French and German, enjoyed reading and debating, chess, carpentry, astronomy, bushwalking and was an accomplished pianist.

### **The Engineer**

Before The Great War, John Monash worked as a civil engineer in Melbourne where he was recognised as an innovator in the use of reinforced concrete. By 1910 his engineering business had withstood recession and was very successful in building bridges and other large construction projects.


### **The Soldier**

General Sir John Monash’s military career began at the age of 19, when he joined the Melbourne University company of the 4th Battalion, Victoria Militia as a volunteer, not a professional soldier. He rose through the ranks of the Militia, the Reserve Army. During the First World War, he led the 4th Brigade at Gallipoli and was later commended for his brilliant command of the Australian Army Corps in France, which resulted in a number of major victories (among them, Hamel, Mont St Quentin and Amiens) that are credited with having shortened the course of the War. In a rare gesture by King George V, he was knighted in the field in 1918.

### **The Revered Public Figure**

Post-war, he became the first Chairman of the State Electricity Commission of Victoria. He lectured at the University of Melbourne and was its Vice-Chancellor for two years from 1923. He was one of the principal organisers of the annual observance of ANZAC Day and the driving force behind the building of Melbourne’s Shrine of Remembrance. John Monash died on 8 October 1931 at the age of 66. His State Funeral was attended by an estimated 300,000 mourners.



**Professor Mark Dawson, 2006 John Monash Scholar PhD, University of Cambridge**

Professor Mark Dawson is a clinician-scientist at the Peter MacCallum Cancer Centre. He is the program head of the Translational Haematology Program, Group leader of the Cancer Epigenetics Laboratory and Consultant Haematologist in the Department of Haematology.

His research interest is studying cancer biology to identify new treatments that improve the outcome for patients with cancer. He is a fellow of the Royal Australasian College of Physicians and Royal College of Pathologists of Australasia.

After completing his clinical training in Melbourne, Australia he was awarded the prestigious John Monash Scholarship and Cambridge Commonwealth Trust Fellowship, which he used to complete his PhD at the University of Cambridge. Following his PhD, he was awarded the inaugural Wellcome Trust Beit Prize Fellowship to pursue his research into a molecular understanding of leukaemia stem cells. This research identified a new therapeutic strategy for acute myeloid leukaemia and helped set the platform for clinical trials around the world with a first in class epigenetic therapy. His research has been published in world leading journals including Nature, Cell, Science and New England Journal of Medicine.

Mark is currently a Professor in the Sir Peter MacCallum Department of Oncology and Centre of Cancer Research at the University of Melbourne. He is also the Senior Research Fellow for the Leukaemia Foundation of Australia and a Howard Hughes Medical Institute International Research Scholar.

# The scholarship selection process



The Foundation's key role is the annual selection of Scholars through a rigorous three-stage process. It follows a framework of governance designed to ensure an enriching experience for each applicant as it evaluates excellence in their chosen fields, demonstrated leadership and the potential to contribute to a better Australia.

The process begins in May each year with candidates assessed on written applications and interviews in each state and territory by panels made up of respected and knowledgeable representatives of academia, industry, government and the community.

A national panel interviews candidates in Melbourne and Sydney in October and recommends the appointment of 15-20 Scholars to the Foundation Board.

The Governor-General of the Commonwealth of Australia, as Patron-in-Chief of the Foundation, presents scholarships to successful candidates at a ceremony held in the first quarter of the following year.

**Ms Jessie Smith, 2019  
Susan and Isaac Wakil Foundation  
John Monash Scholar**

Jessie is a solicitor who held joint conduct of the largest terrorism and national security law practice in Australia. She completed her BA (Honours) and an LLB (Honours) at the University of Melbourne. Jessie has worked closely with terrorist offenders to develop a blueprint for the nation's first forensic de-radicalisation program to assist a court pre-sentence. With her John Monash Scholarship, Jessie is studying a PhD in law at Cambridge, exploring how courts might encourage and evaluate the renunciation of violence with significant implications for Australia's domestic security.

*"For several years I have practiced as a solicitor in the complex field of counter-terrorism law. I decided to pursue a PhD in order to address questions of offender rehabilitation. To this end, my doctorate will consider how courts evaluate the renunciation of political violence. The broad aims of my research are to foster a more accurate assessment of terrorist risk and create pathways for disengagement from violence.*

*Thanks to the generosity of the Susan and Isaac Wakil Foundation and the John Monash Scholarship, I now have the opportunity to undertake my studies at the University of Cambridge. The UK has been impacted by political violence for centuries. Australia can learn a lot from the British legal response to terrorism and how best to strike the balance between liberty and security. I intend to return to Australia with fresh ideas for our jurisdiction."*





Garang was born in South Sudan and grew up in a Kenyan refugee camp before moving to Australia when he was 17. He has a Bachelor of Biomedical Science from Monash University, an MD from The University of Melbourne and worked as a surgical registrar at Alfred Health. He is also a Fellow of the Williamson Community Leadership Program. Garang volunteers in public health education and has been an Australia Day Ambassador for the last four years. Following his graduation from Harvard with the Master of Public Health which focused on improving access to quality surgical care in resource-poor settings, Garang returned to Australia to take up a Policy Fellowship at the Department of the Prime Minister and Cabinet in Canberra. Through classes at Harvard such as ‘entrepreneurship in healthcare IT and services,’ a practicum at Aravind Eye Care System in India and experiences at Ariadne Labs (health systems innovation centre), Garang became convinced he would enhance his impact by combining policy training and private sector tools. He is now undertaking an MBA at Oxford University with the support of the Said Business Foundation. This program’s focus will complement Garang’s training in medicine and policy, augmenting a comprehensive approach to global surgery and health systems.





## Governance

The General Sir John Monash Foundation is governed by an eminent national board chaired by Ms Jillian Segal AO and comprised of Chancellors, Vice-Chancellors, Senior Directors, representatives of professional service organisations, business and community leaders. The Foundation is a public company limited by guarantee with named status as a Deductible Gift Recipient. The funds of the Foundation are managed under the guidance of the Investment, Audit and Risk Committee with the assistance of professional investment advisors. The Foundation is audited annually by KPMG.

She is also a Venture Partner at NextGen Venture Partners, a network-driven venture capital firm. May's primary areas of interest include venture financing, technology policy, the future of education and work, social entrepreneurship and adaptive leadership. She has published on these topics in multiple outlets, including TechCrunch, Forbes, VentureBeat, Stanford Social Innovation Review and San Francisco Chronicle.

May serves as a Member of the Board of Advisors for Persian Women in Tech, an organisation supporting Persian & MENA women in STEM. She is also an advisor, facilitator and mentor at Nalukai Academy's summer startup camps in Hawaii.
