









General Sir John Monash: A man for all times

General Sir John Monash was recognised as a great leader on the battlefields of northern France in the First World War.

However, this seminal role was only part of his enduring legacy. He was an outstanding Scholar, engineer, public servant and civic leader – the driving force behind the ANZAC commemorations and founding member of community bodies such as Rotary, as well as the remarkable repatriation of around 160,000 Australian troops; newly trained with professional and trade skills acquired in France and England while waiting for their safe passage to Australia.

An iconic nation-builder, John Monash was guided by a strong sense of duty and obligation, employing his talents and education to build a more cohesive society – overcoming prejudice and creating opportunities for others as he went.

He is an inspiration to all Australians and the guiding spirit of the Foundation.

The Young Man

John Monash was born in West Melbourne, Victoria, on June 27, 1865 to Jewish migrant parents from Prussia. In 1874, the family moved to the small New South Wales town of Jerilderie. They returned to Melbourne three years later and John Monash enrolled at Scotch College. At the age of 16, he graduated as equal Dux of the school.

The Scholar

John Monash graduated from The University of Melbourne with degrees of Master of Engineering in 1893, Bachelor of Arts and Bachelor of Law in 1895 and Doctor of Engineering in 1921. He spoke French and German, enjoyed reading and debating, chess, carpentry, astronomy, bushwalking and was an accomplished pianist.

The Engineer

Before The Great War, John Monash worked as a civil engineer in Melbourne where he was recognised as an innovator in the use of reinforced concrete. By 1910 his engineering business had withstood recession and was very successful in building bridges and other large construction projects.


The Soldier

General Sir John Monash's military career began at the age of 19, when he joined the Melbourne University company of the 4th Battalion, Victoria Militia as a volunteer, not a professional soldier. He rose through the ranks of the Militia, the Reserve Army. During the First World War, he led the 4th Brigade at Gallipoli and was later commended for his brilliant command of the Australian Army Corps in France, which resulted in a number of major victories (among them, Hamel, Mont St Quentin and Amiens) that are credited with having shortened the course of the War. In a rare gesture by King George V, he was knighted in the field in 1918.

The Revered Public Figure

Post-war, he became the first Chairman of the State Electricity Commission of Victoria. He lectured at the University of Melbourne and was its Vice-Chancellor for two years from 1923. He was one of the principal organisers of the annual observance of ANZAC Day and the driving force behind the building of Melbourne's Shrine of Remembrance. John Monash died on 8 October 1931 at the age of 66. His State Funeral was attended by an estimated 300,000 mourners.





Professor Dawson is a clinician-scientist and an Associate Director at the Peter MacCallum Cancer Centre. His research interest is studying epigenetic regulation in normal development and cancer. His research has helped identify several first-in-class epigenetic therapies resulting in various clinical trials across the world. He is a Professor at the University of Melbourne, the Sir Edward Dunlop Fellow for the Cancer Council of Victoria and a HHMI International Scholar.

In recognition of his research achievements, he has been elected to the Australian Academy of Science, Australian Academy of Health and Medical Sciences and as an EMBO member. In addition to being awarded a 2006 John Monash Scholarship, he has received several prestigious awards including the McCulloch & Till Award from the International Society of Experimental Haematology, the Jacques Miller Medal from the Australian Academy of Science and the Prime Minister's Prize as Life Scientist of the year in 2020.

The scholarship selection process

The Foundation's key role is the annual selection of Scholars through a rigorous three-stage process. It follows a framework of governance designed to ensure an enriching experience for each applicant as it evaluates excellence in their chosen fields, demonstrated leadership and the potential to contribute to a better Australia.

The process begins in May each year with candidates assessed on written applications and interviews in each state and territory by panels made up of respected and knowledgeable representatives of academia, industry, government and the community.

Two national panels interview candidates in Melbourne and Sydney in October and recommends the appointment of 15-20 Scholars to the Foundation Board.

The Governor-General of the Commonwealth of Australia, as Patron-in-Chief of the Foundation, presents scholarships to successful candidates at a ceremony held in the first quarter of the following year.

Chloe D'Souza

Chloe is a Noongar woman who grew up on Whadjuk Noongar Boodja (Perth). She is a lawyer with a background in energy regulation, heritage and native title. Chloe also has experience in advocating for better outcomes for Aboriginal and Torres Strait Islander people particularly, particularly across justice and education. With the Bob Hawke John Monash Scholarship, Chloe completed a Master of Laws at Harvard University in 2021/22. During her LL.M, Chloe focussed on the ways that law and policy have historically and continue to harm Indigenous, and African American people and communities in the USA. She undertook challenging classes including race and the law, mass incarceration, and transformative and restorative justice.

Chloe currently works as an advisor to the Hon Mark-Dreyfus KC MP, Attorney-General, working on First Nations Justice policy and the referendum to enshrine an Aboriginal and Torres Strait Islander Voice to Parliament.

"I often feel overwhelmed when I think about what I've achieved in the last few years. I was the first person in my family to graduate from university. When I graduated from law school, I couldn't have ever dreamed of going on to study at Harvard University.

Being the Inaugural Bob Hawke John Monash Scholar means a lot to me. I care deeply about changing the outcomes that Aboriginal and Torres Strait Islander people face in Australia. I care about First Nations people having an opportunity to have a say on the matters that impact their lives, and I feel honoured to work for a government that cares about this too. The John Monash Foundation has provided unwavering support for the academic and career path that I've chosen.

I've landed where I belong and I know I have a whole community beyond my family standing behind me and supporting me.

I continue to meet such wonderful, intelligent, and innovative Australians through the John Monash Foundation. I'm extremely grateful for the opportunity to learn from scholars and alumni, and to also share my experience. I love seeing the impact that John Monash Scholars are making both in Australia and abroad, across a range of different fields. I'm lucky to be an alum!"

Iwan Walters was awarded a 2012 John Monash Scholarship, which enabled him to complete an MPhil in Economic and Social History at the University of Oxford and a Master of Public Policy at Oxford's Blavatnik School of Government.

He was elected to the Victorian Parliament in November 2022, becoming the first Member for Greenvale in the Legislative Assembly. As part of the current Victorian Government, Iwan was recently elected Chair of the Scrutiny of Acts and Regulations Committee for the 60th Parliament of Victoria.

Prior to entering Parliament, Iwan's working life was focused on education and ensuring that young people can access quality education wherever they live.

Iwan was a secondary school teacher in country Victoria, where he experienced how public services and government policies have a practical impact on families and shape communities. His approach to public office is influenced by that experience and underpinned by the principle that every person should have the opportunities they need to learn, develop, and thrive, and that economic chances and prosperity should be shared equitably across our communities.



Garang was born in South Sudan and grew up in a Kenyan refugee camp before moving to Australia when he was 17. He has a Bachelor of Biomedical Science from Monash University, an MD from The University of Melbourne and worked as a surgical registrar at Alfred Health. He is also a Fellow of the Williamson Community Leadership Program. Garang volunteers in public health education and has been an Australia Day Ambassador for the last four years. Following his graduation from Harvard with the Master of Public Health which focused on improving access to quality surgical care in resource-poor settings, Garang returned to Australia to take up a Policy Fellowship at the Department of the Prime Minister and Cabinet in Canberra. Through classes at Harvard such as 'entrepreneurship in healthcare IT and services,' a practicum at Aravind Eye Care System in India and experiences at Ariadne Labs (health systems innovation centre), Garang became convinced he would enhance his impact by combining policy training and private sector tools. Garang completed a MBA at the University of Oxford to complement Garang's training in medicine and policy, augmenting a comprehensive approach to global surgery and health systems. Dr Dut is a fellow at the ANU College of Health and Medicine.

Jillian has a Bachelor of Civil Engineering with First Class Honours. She was the Australian Young Professional Engineer of the Year and Sydney University's Young Alumni of the Year.

In 2009 she established her boutique infrastructure advisory firm, The Infrastructure Collaborative, and in 2020 co-founded The Stable Group of which she is now Managing Director. Jillian used her John Monash Scholarship to study a Master of Business Administration and Master of Public Policy at Stanford University. Upon returning to Australia, Jillian continued her infrastructure advisory work, firmly fixed in her pursuit of change for Regional Australia. In 2018, as the NSW Rural Woman of the Year, Jillian purchased a 133-year-old heritage post office in Dubbo. Following a full renovation, Jillian became the founder and CEO of The Exchange, a community first coworking space built to "empower the brave to grow, connect and succeed", purchasing and renovating a second heritage building for the organisation in Narrabri in 2022. Jillian also serves on the board of the James Martin Institute for Public Policy, The NSW Skills Board, is the Chair of the Daily Telegraph Rural Advisory Panel, member of the NSW Council for Women's Economic Opportunity and a keen backcountry skier and mountain biker.





Dr. Danielle Malek Roosa is currently a Senior Counsel at the World Bank and is admitted to practice as a solicitor in NSW. She is a graduate of the University of Sydney (BA (Hons), LLB, PhD) and Harvard University (LL.M). Prior to joining the World Bank, Danielle worked at the National Native Title Tribunal, as one of four national delegates responsible for making administrative decisions on native title applications country-wide. Danielle began her career at the World Bank as an advisory lawyer for the environmentally and socially sustainable development and international law advisory practice group. She worked on the Banks lending operations for 12 years across four regions and currently advises the President of the World Bank, and its Boards of Governors and Executive Directors, on legal, institutional and governance matters.

Danielle has served with the Australian Army Reserves and has been President of the Australians in Washington Association (AWA), the largest Australian expatriate association in the Washington DC area. In the U.S., she has worked pro-bono as a court appointed special advocate for abused and neglected children. She is married with five young children, including two sets of twins and lives in Sydney.
